FANTASY DANCE STUDIO RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

Please read this form carefully before signing. In consideration of being permitted to participate, in any way, in the Fantasy Dance Studio's Program indicated below, and/ or being permitted to enter for any reason into the restricted area (here in defined as any area where in admittance to the general public is prohibited). The student, parent(s) and/or legal guardian(s) of the minor participant named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below activity, or event, that he/she should inspect the facilities and equipment to be used. If he/she believes anything is unsafe then the participant should immediately advise the officials of such condition, and from there refuse to participate. I understand and agree that if, at any time, I feel any conditions to be UNSAFE I will immediately take all precautions to avoid any unsafe area, and therefore REFUSE TO PARTICIPATE further.
2. I/WE fully understand and acknowledge that:
 - (a) There are risks and dangers associated with any participation in Dance Events and Activities. Any of which could result in bodily injury, partial and/or total disability, paralysis and death.
 - (b) The social and economic losses and/or damages which could result from these risks and dangers described above could be severe.
 - (c) These risks and dangers may be caused by the action, inaction or negligence of the participant, or the action, inaction or negligence of others including, but not limited to, the Releases named below.
 - (d) There may be other risks not known to us, or are not reasonably foreseeable at this time.
3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death however caused, and whether caused either in whole, or in part, by the negligence of the Releases named below.
4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the dance facility used by the participant including its owners, managers, promoters, lessees of the premises used to conduct the dance event or program, premises and event inspectors, underwriters, consultants, and others who give recommendations, direction, or instructions to engage in risk evaluation or loss control activities regarding the dance facility, or events held at such facility. This includes their directors, officers, agents, employees all for the purposes here in referred to as "Release" FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assign, executors, heirs and next of him FOR ANY, AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES. INCLUDING ANY, AND ALL CLAIMS THEREFORE ON ACCOUNT OF ANY INJURY INCLUDING, BUT NOT LIMITED TO, THE DEATH OF THE PARTICIPANT OR DAMAGE TO THE PROPERTY ARISING OUT OF, OR RELATING TO THE EVENT(S) CAUSED, OR ALLEGEDLY CAUSED IN WHOLE, OR IN PART BY THE NEGLIGENCE OF THE RELEASE OR OTHERWISE.
5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS, and involve the risk of serious injury, and/or death, and/or property damage. Each of THE UNDERSIGNED also expressly acknowledge that INJURIES RECEIVED MAY BE COMPOUNDED, OR INCREASED BY THE NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASES.
6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad, and as inclusive as is permitted by the Law of the Province, or State in which the event is conducted. If any portion is held invalid it is agreed that the balance shall not withstanding continue in full legal force and effect.
7. On behalf of the participant, and individually the undersigned parent(s) and/or legal guardian(s) for the minor participant makes a claim against any of the Releases, execute this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releases, the parent(s) and/or legal guardian(s) will reimburse the Releases for any money which they have paid to the participant, or on his behalf, and hold themselves harmless.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, AND FULLY UNDERSTAND THAT DUE TO ITS TERMS HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I HAVE SIGNED THIS AGREEMENT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME. I INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

I understand that the debit/credit card transaction will occur on the 1st of the month for all enrolled classes if this is your preferred method of payment. If no other payment has been made I authorize Fantasy Dance Studio to charge my card any outstanding balances, including the additional \$25 late fee. I understand that all drops or withdrawals must be made in writing prior to that time. Families are responsible for all class fees regardless of attendance.

STUDIO POLICIES: (Please initial next to each policy to acknowledge understanding.)

- _____ **LATE RULE:** Students must be on time for each class – no one will be admitted to class if they are more than 15 minutes late. We suggest you arrive 15 minutes prior to your class to have time to change, stretch and prepare for the class. Late students may be asked to observe class.
- _____ **MAKE-UPS: THERE ARE NO MAKE-UPS** offered unless scheduled with a member of our Office Staff. If your student becomes ill, and is forced to miss a class then it is your responsibility to coordinate a designated make-up class with the Office within ONE MONTH of each missed class. Make-up classes are completely optional. No credit will be given for missed classes, or if your dancer can not attend any make-up classes scheduled by the Office. If you are aware ahead of time that you will be missing a class you can schedule a make-up class prior to the absence. Do not arrive at a class without coordinating with the Office.
- _____ **DRESS CODE REGULATIONS:** Each student must come to class in appropriate attire that coordinates with our Dress Code Regulations. This includes clothing, shoes, and hair for each class. Please refer to our Regulations available both online, and in the Office. Please wear street clothes over your dancewear when outside of the studio. Street shoes must be worn to and from the studio. No dance shoes outside.
- _____ **TUITION DUE DATE & LATE FEE:** Tuition is due the FIRST LESSON OF EACH MONTH, and does NOT deviate regardless of Holiday Closure. A student will be charged tuition for the entire month unless the FDS office is notified of a drop before the FIRST of the month. FDS accepts three forms of payment: CHECK, CASH and CREDIT CARD. CHECKS must be made payable to “Fantasy Dance Studio”. Any returned checks are subject to a \$25 fee. If a payment is made in CASH please be sure it is in a sealed envelope with the Student’s name clearly marked. There is a payment box located on the Office Door for all tuition payments. CREDIT CARDS: We accept debit/credit cards (Visa/Master Card). You must at all times have a Credit Card on file. The Credit Card must always be up to date, and can also be used for tuition purposes. You can set up automatic payments through our office to have your card charged on the 1st of each month. This will help to ensure there are not late fees added to your account. After the 10th of each month if no payment has been made by any other method YOUR CREDIT CARD IS SUBJECT TO BE CHARGED THE TUITION IN FULL, AND ALSO INCLUDING AN ADDITIONAL \$25 LATE FEE. There will be no exceptions to this rule, and a Credit Card is now mandatory on ALL accounts. There will be no refunds or make-ups for missed classes. There are no tuition reductions for students that go out of town or become ill. NO REFUNDS will be offered for any reason. If you plan to miss a long period of time it is your responsibility to coordinate any make-up classes with the office within a month of the absence. No partial tuition is offered.
- _____ **REGISTRATION FEE: 1 Student- \$40, 2 Students- \$25, and 3+ Students- \$10.** This fee will be applied annually to each student that chooses to enroll in classes. This fee is a NON-REFUNDABLE PAYMENT. The Registration Fee is due with August/September Tuition, or with the first month’s tuition after registration. Students who choose to pay the entire 2016-2017 (August-June) year in advance upon registration will have the option to waive the Registration Fee. Any returning student who registers BEFORE August 17th will have the registration fee waived for this year.
- _____ **COSTUME USAGE FEE: 1st FDT Member- \$95, 2nd+ FDT Members- \$70 each, Non-Troupe Student- \$35 per class.** There is a costume usage fee for ALL students that wish to participate in any of our offered concerts or performances. This is an annual fee that must be paid at the same time as the Registration Fee at the beginning of the school year.
- _____ **PERFORMANCE FEE: 1st FDT Member- \$60, 2nd+ FDT Members- \$45 each, Non-Troupe Student - \$30.** Performance fee is for all students in order to participate in our concerts which will also be an annually charged fee. This fee is mandatory, and also due at the same time as both the Registration Fee and Costume Usage Fee.
- _____ **PARENTS’ RESPONSIBILITY TO BE AWARE OF DATES AND EVENTS:** It is the responsibility of the parent or adult student to be aware of the studio’s activities such as performances and dates the studio is open and closed. The studio will post notices online and through the email mailing list. It is also the responsibility of the parent or adult student to inform the studio of any address, telephone and/or email change.
- _____ **MEDIA WAIVER:** All students are subject to be photographed or videoed for studio purposes only. No photographs or videos will ever be used or sold for any other purpose other than studio use or marketing tools. Photos may also appear on the website if approved by the studio owner.
- _____ **CHILD PICK-UP:** Please pick up your child after their class or classes have been completed. Please do not leave your child at Fantasy Dance Studio any longer than 15 minutes after their class schedule has finished. THANK YOU.
- _____ **REHEARSAL POLICY:** It is your responsibility to be aware of all rehearsals your dancer needs to be at. The studio sends out multiple emails regarding scheduling for rehearsals. If you miss 2 or more rehearsals you risk being taken out of the performance. This decision will be according to Artistic Director/ Teacher discretion. If you know you will be absent for one or more rehearsals please coordinate with the office as soon as possible. The first concert will take place at the beginning of December, and our Annual Concert will take place mid-June. Rehearsals for these performances usually begin two weeks prior to the concert. Your student will be expected to be present at all rehearsals their classes are called for.
- _____ **CONCERT INFORMATION:** Fantasy Dance Studio presents two concerts each year. Our December Concert is primarily for FDT Members. Other classes will also be performing based on Artistic Director/ Teacher selection. This concert is much smaller, and therefore will have less dances selected. Our Annual Concert(s) in June is/are our largest concert(s), and all classes will be expected to perform. Please be aware that rehearsals for these concerts usually take place as far as TWO WEEKS prior to each concert if your class is selected. The dates for the Performances this year are TBA.
